- Entry Fee:** **\$42 per race, payable to Park City Ski & Snowboard at registration. Registration will begin at 5PM at the Best Western Cotton Tree Inn, Sandy UT (Maple Room)**

Coaches tickets will be distributed each night at Team Captains Meeting.
